## PICKLEBALL FACILITY RULES

- 1. Pickleball play is open & available 7 days per week from the hours of 8:00 a.m. to 8:00 p.m. specifically on Court(s) #2 & #3 *ONLY*. Waiting for courts before 7:30 a.m. is not allowed.
- 2. Court time is limited to *90 minutes*, from sign-in time. Pickleball, singles as well as doubles on all courts. Residents/homeowners waiting for courts must remain outside the court and in the immediate area in order to retain the position in line for court use. Leaving the recreation facilities (courts) will result in forfeiting the court reservation.
- 3. Court usage is on a first-come, first-serve basis. Residents/homeowners must sign up prior to playing. Guests are prohibited from signing-up for Reserving courts. Residents/homeowners must also include the starting time on the list **BEFORE** starting to play.
- 4. No Marina Hills court may be used unless accompanied by a resident/homeowner. No guests may enter or use a Marina Hills' court unless a resident/homeowner is present. Guests are required to wait outside of the courts until the resident/homeowner arrives. No more than 6 players on any specific one (1) court and a Marina Hills resident/homeowner must be present at all times on that specific court. Proof of residence may be required by the patrol officer on duty or clubhouse manager identification should be available at all times if asked for by Association personnel.
- 5. Individual practice is only allowed if the pickleball court is not in use by other players and must be relinquished when or if other players wish to play a game or match on the pickleball court.
- 6. Non-marking soled shoes and proper court/facility attire (shirts required) must be worn by all persons using the courts. Shoes which leave a mark on the court surface are not allowed. No bare feet allowed.
- 7. Common courtesy and respect should be shown by all persons using the facility courts. No music, strong or profane language is to be used. No smoking or vaping on the court(s). Poor behavior, abuse of windscreens, nets, equipment, verbal threats, disruptive behavior, or tampering with other Pickleball or Tennis players court time, Security Staff or Association Staff, etc. may result in players being requested to leave, called to a hearing in front of the Board to face a monetary fine and the possibility of the Tennis & Pickleball Facility privileges being suspended for 30 calendar days.

- 8. Misuse or vandalism of the tennis/pickleball facilities may cause suspension of privileges. When a resident/homeowner or their guest(s) is found damaging the courts, that resident/homeowner will be held financially responsible for repairs.
- 9. Food and drinks are not allowed on the court(s). Bottled water is permitted. All trash is to be disposed of properly.
- 10. Players are not to cross occupied courts to reach an assigned court or retrieve balls without proper notification or agreement from the court occupants.
- 11. When leaving the court, gates are to be securely locked and lights turned off. Access to courts is for residents/homeowners and their guests only.
- 12. No pets are permitted inside the pickleball facility court.
- 13. No other activity is allowed on the pickleball court and center walkway. This includes skates, skateboards, bicycles, e-bikes, roller blades or other wheeled vehicles.
- 14. Pickleball players must use Arizona Standard equipment or other equipment meeting USA Pickleball Association (USAPA) specifications.
- No professional (*paid for*) pickleball lessons shall be given during prime hours or on any/all Federal Holidays: Monday- Friday: between 8:00 - 11:00 a.m. or between 6:00 - 8:00 p.m., Weekends: Before 11:00 a.m., Holidays: New Year's Day, Martin Luther King Jr. Day, President's Day/Washington's Birthday, Memorial Day, Independence Day, Labor Day, Columbus Day, Veterans Day, Thanksgiving and Christmas Day.

If a resident/homeowner wishes to engage the services of a sports instructor for lessons or coaching, they must contact the Clubhouse Manager, at the recreation center office, to obtain an agreement form. The form must be completed and accepted by the association, prior to the sports instructor providing any services utilizing association property.

Anyone attempting to provide any such services on association property, without having previously completed the agreement, will be required to immediately cease such activities, and leave the recreation center area.
